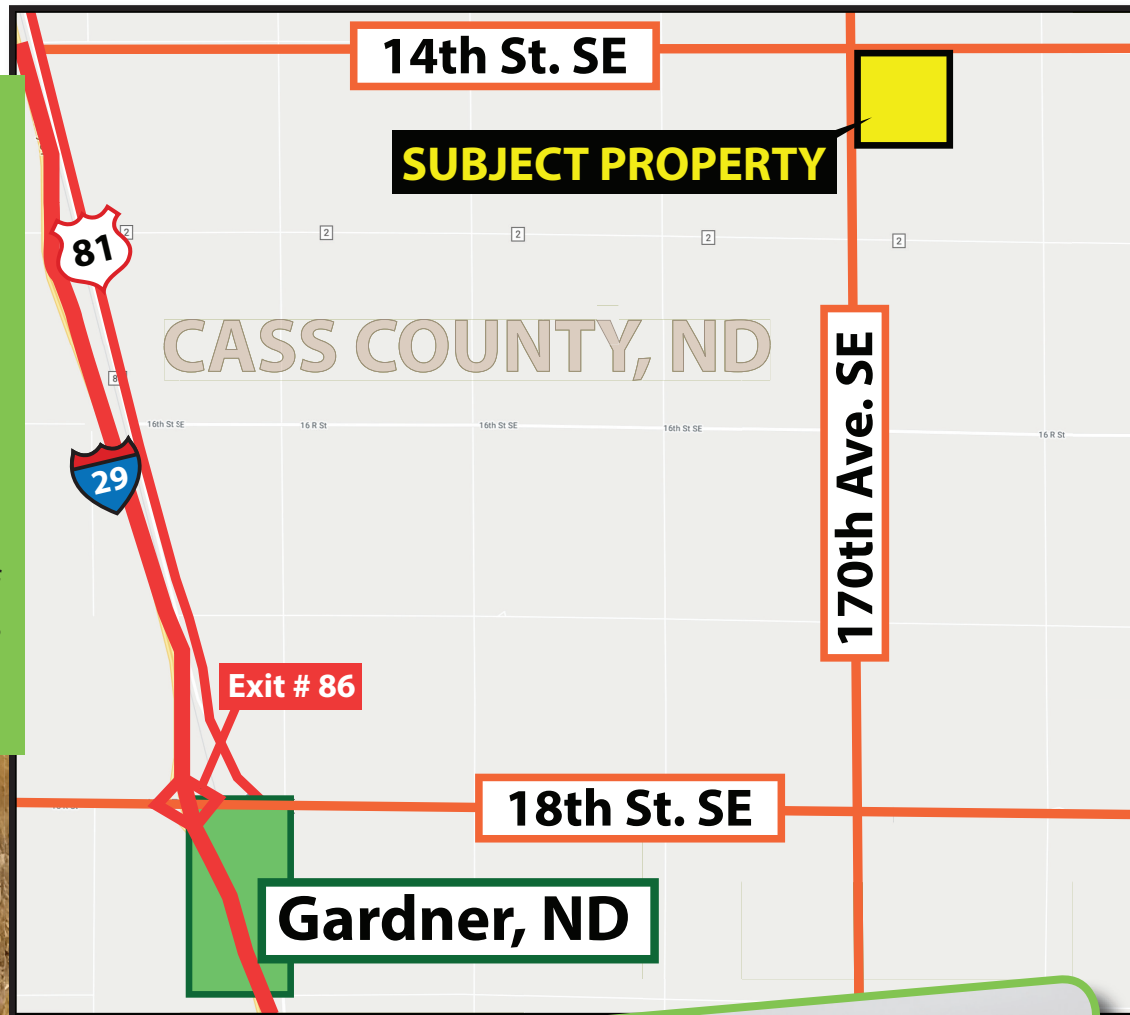

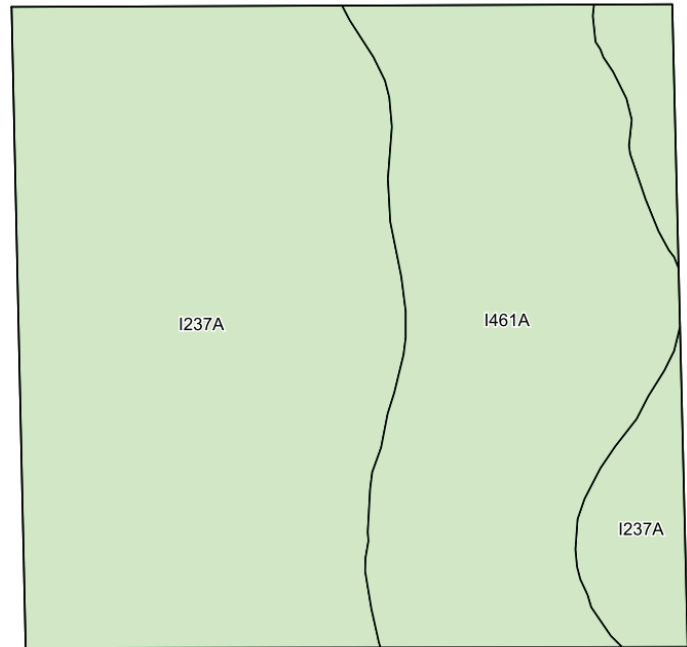
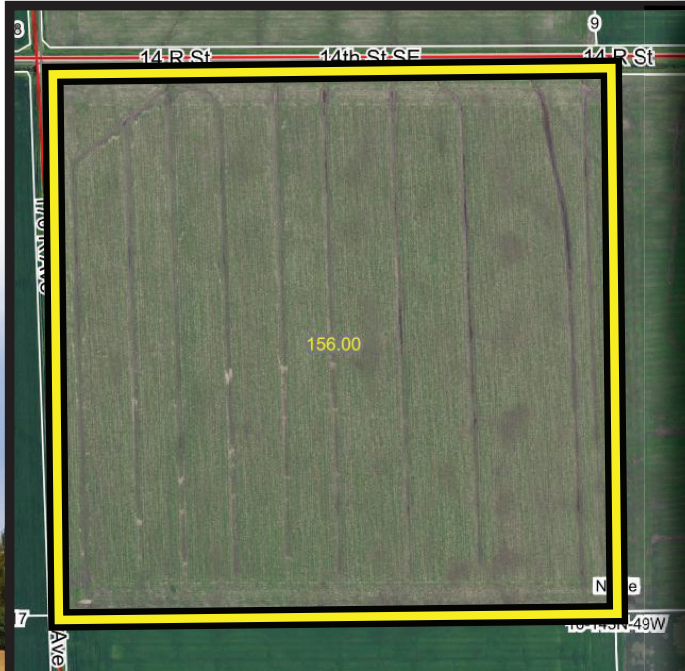

Terms and Conditions

I. Terms and Conditions of Auction
